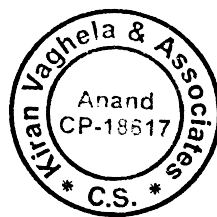
Reconciliation of Share Capital Audit Report

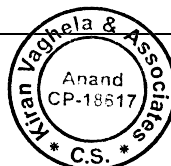

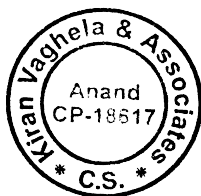
